Let's Move "Back from the Brink" of Nuclear Apocalypse

The current U.S. program to "modernize" our nuclear arsenal is projected to cost up to \$1.7 trillion, after inflation, over the next 30 years, and with similar modernization programs of Russia, China, and other nuclear weapons states (NWS), have created a new nuclear arms race. President Trump announced last February that the U.S. would withdraw from the Intermediate Nuclear Forces (INF) Treaty, and subsequently President Putin announced reciprocal Russian intent to withdraw. Continued nuclear flashpoints in South Asia and Korea, and the recent threats of a U.S. war on Iran, have added to this combustible mix, as have nascent offensive global programs to develop and deploy new hypersonic missiles that could initiate a nuclear, or very powerful conventional attack on targets across the globe on the order of 15 minutes, defying any possible "defense." Of equal

concern are the greatly increased global capabilities of cyberwarfare exemplified by the recent revelation of a U.S. program, active since 2012, which inserted cyberweapons into the Russian power grid. These actions, mirrored by Russian and other active state programs, threaten all critical infrastructure, including industrial facilities such as chemical plants and oil refineries that could lead to devastating impacts on public and environmental health. Equally vulnerable are the hundreds of global nuclear power plants that could be remotely sabotaged to provide the dread equivalent of a nuclear terror attack or meltdown.

In recognition of these mutually reinforcing threats to human existence, **Physicians for Social Responsibility** has joined with partners such as the **Union of Concerned Scientists, Federation of American Scientists, 350.org**, and numerous others in developing a national, grassroots "Back from the Brink" (*BftB*) campaign, which subsumes many of the goals of the 2017 Treaty to Prohibit Nuclear Weapons. *BftB* calls on our government to: (1) End the sole, unchecked authority of any President to initiate a nuclear attack; (2) Have the U.S. adopt a No First Use policy; (3) Take the U.S. nuclear arsenal off hair-trigger alert; (4) Cancel the U.S. plan for modernizing its nuclear weapons arsenal; and (5) Initiate negotiations with all other NWS to achieve a verifiable, enforceable, and time-bound accord to eliminate all nuclear arsenals. Some individual calls of *BftB* such as "No First Use" have been incorporated within proposed current national legislation that aims for bipartisan support. In addition, a more comprehensive resolution, "**Embracing the Goals and Provisions of the Treaty on the Prohibition of Nuclear Weapons**" (**H.R. 302**) has been introduced by Representatives Jim McGovern (D-MA) and Earl Blumenauer (D-OR), which embraces all of the goals of the *BftB* campaign. Such Congressional actions have been complemented by a robust grassroots movement working within towns, cities and states throughout the nation to pass local resolutions in support of the *BftB* campaign. As with the increasing engagement of physicians and other health professionals around the health impacts of climate change, our voices opposing the real and present dangers of nuclear war are critically needed, and reinforced by long-standing policies within the APHA calling for the elimination of nuclear weapons. APHA To Vote on War & Conflict-Related Policies

Let your support be heard at the Joint Policy Committee Public Hearings on Sunday 3:30 - 6:00, PCC 203B (Session 272.0)

Ask **APHA to call for the United States to end its support of the war in Yemen**. Since 2015, the civil war in Yemen has led to what the United Nations calls "the world's worst humanitarian crisis". Bombings of the country and its health infrastructure, along with port blockades that keep desperately needed water, food, and medicine out of the country, have left millions malnourished or at risk of famine. Three MPH students at the **University of Washington** partnered with the **Yemen Relief and Reconstruction Foundation** to research the effects of the US-supported, Saudi-led war on Yemen. Their product was a policy statement that will be considered at this year's APHA annual meeting calling for the US to end its support of the war. A second policy statement, **A call to end violent attacks on health workers and health facilities in war and armed conflict settings**, authored by members of the International Health Section, and endorsed by the Peace Caucus, Medical Care Section, Occupational Health and Safety Section, and Forum on Human Rights, seeks to protect health workers in conflict settings who are increasingly under attack for their work, despite the legal protections afforded to them by the Geneva Conventions and other international law. It calls on APHA to recommend: 1) improved monitoring, tracking, investigating and reporting of targeted violence against health workers, 2) improved compliance with international law via training and legal reform, and 3) holding perpetrators accountable while removing political and material support for their actions.

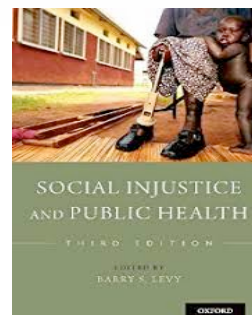
