PC Honored by Soviet Medical Workers

An extraordinary honor was bestowed on the PC at the Annual Meeting. The honor came in the form of the presentation of a replica of the "Let Us Beat Swords Into Ploughshares" statue. The arrangements for the presentation were made by APHA Past President and PC member, Dr. Victor Sidel. The statue was presented to Larry Kushi by Dr. Lydia Novak, President of the seven million member Soviet Medical Workers Union. The statue is a model of the sculpture located on the grounds of the United Nations in New York City.

The original statue is the work of Soviet sculptor Evgeniy Vuchetich. According to a press statement on December 4, 1959, during the presentation of the sculpture, "... the statue represents the figure of a man holding a hammer in one hand and, in the other, a sword which he is making into a ploughshare, symbolizing man's desire to put an end to war and convert the means of destruction into creative tools for the benefit of all mankind."

The PC hopes to put the statue "on tour" and send it to as many APHA State Affiliates as possible during the coming year. Ideally, a display would occur at the annual meetings of the affiliates. The PC leadership has also authorized the development of a drawing of the statue for use as the official logo of the PC. Please let us know, as soon as possible, if you would like to have the statue sent to your affiliate for display purposes. We will try to arrange a tour schedule



to accommodate everyone. The only requirement, of course, is that the affiliate include members who are also members of the PC. Please contact Pat Johnson, in care of the newsletter, and include the dates of your annual meeting.

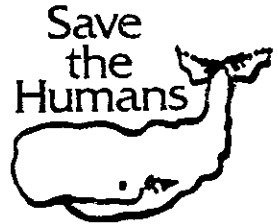
Jesse Jackson:

The Reverend Jackson's speech entitled, "Enough of Band aids: The Need for a National Health Program," was delivered to several thousand APHA members in a packed auditorium. Reverend Jackson's theme of "Health, not Wealth" coupled with a reverberating cry of, "it's time for a new direction", brought the audience to its feet. While the PC has taken no official position in the coming presidential campaign, it is clear that Rev. Jackson said much that agreed with many public health workers in New Orleans.

Candidates Respond to Nuclear Testing Questions

The APHA Government Relations staff mailed questionnaires to all the announced 1988 Democratic and Republican presidential contenders. They were questioned on issues from national health insurance to gun control, from AIDS to abortion. The responses to a question on nuclear testing and Star Wars are reported below.

Q: Do you support a halt to nuclear testing? What is your position on Star Wars?

Babbit:

I strongly support a comprehensive ban on the testing of nuclear weapons, and I would support an immediate and mutual moratorium on nuclear tests during its negotiation.

I support a mutual moratorium - by agreement with the Soviets - on the development, testing and deployment of strategic defense. You don't stop one arms race by starting another, and strategic defense will inevitably begin a cycle of measure and countermeasure that detracts from our security at exorbitant economic cost. As President I would pursue a substantial research program into strategic defense, as a hedge against technological surprise. But I would shift the emphasis of our research to basic physical principles and computational problems - away from engineering and development.

Dukakis:

I support a comprehensive nuclear test ban treaty. I am opposed to Star Wars development, testing or deployment. I would cut research back to its level before President Reagan announced the SDI initiative in 1983.

Gephardt:

As President, I would halt all testing of US nuclear weapons over one kiloton, and challenge the Soviets to make good on their pledge to join us in doing so. I would eliminate funding for production and deployment of Star Wars.

Gore:

I oppose absolutely any plan for development or deployment of SDI. Research on SDI should be confined to a strict interpretation of the ABM treaty. The focus of this research should be to assure that we have state-of-the-art understanding of the basic science and technology that could be relevant to defense.

As for nuclear weapons testing, I would support a moratorium on testing for a limited time. My longer term objective would be an agreement which very sharply limits testing but still permits the minimum number of tests needed to ensure that the existing weapons on which we still rely for deterrence work.

Simon:

As one of my first acts in office, I will challenge the Soviets to immediately end all nuclear testing. I pledge to negotiate a permanent verifiable end to all nuclear testing. This is essential if we are to reverse the arms race and stop the introduction of new, destabilizing weapons.

Star Wars is built on a dangerous illusion that there are weapons of peace that can eliminate weapons of war. The only way to eliminate nuclear weapons is to negotiate them away. As a new member of the Senate in 1985, I sponsored an amendment to the defense bill that would have frozen Star Wars spending at the fiscal year 1985 level. Earlier this year I introduced a resolution saying "no" to an early deployment of Star Wars.

Book Review

Daniel Axelrod and Michio Kaku have written a well-documented, if chilling, account of the history of U.S. nuclear weapons policy, To Win a Nuclear War: The Pentagon's Secret War Plans. (South End Press, Boston, \$11) The authors build a convincing case that US policy from 1945 to the present has been to threaten, fight, survive and even "win" a nuclear war.
